An exciting Regular Full-Time opportunity as a **Technical Specialist - Network (Competition #192.18)** exists in the Information Management/Information Technology reporting to the Manager, Technology Services. This role is responsible for the operation and maintenance of the Enterprise IT networking services (VPN, IPS, NAC, Firewalls, Routers, Switches, Wi-Fi infrastructure, IDS/IPS, VOIP, Load Balancers, etc.) including recommending, designing, implementing, operating and supporting the systems as required at all stages of the network infrastructure lifecycle.

## Summary of Duties, but not limited to:

- Maintain network performance by performing network monitoring and analysis and performance tuning; troubleshooting network (WAN, LAN, Wireless) problems; reporting on performance to IM/IT Management on a regular basis.
- Install, test, configure, monitor and support all network hardware and equipment, including network backbone, core and edge switches, routers, gateway appliances, load balancers, Wi-Fi, IDS/IPS, network monitoring services, QOS for VOIP, UPS and power switches, etc.
- Administer remote access infrastructure, virtual private networking, administer firewall exceptions for remote users and sites, responsibility for the DMZ, etc.
- Setup and maintain IP addresses and IP design, name resolutions (DNS), VPN tunnels, network routing, VLANs, Load Balancers, Firewall rules and policies.
- Responsible for coordinating, monitoring and supporting carrier fiber network provisioning for WCH sites, links to partner hospitals, eHealth ONE network, Internet, public-facing IP addresses, etc.
- Provision and support network VLANs for various hospital and third party IP-based services, including VOIP, patient monitoring, nurse call system, security access control, CCTV videoconferencing, cable TV over IP, code white panic pendants, labs, medical imaging modalities, etc.
- Shared responsibility for security, stability and monitoring of the hospital Datacentre and LAN room facilities.
- Recommend, design, plan and implement improvements, modifications and lifecycle/warranty replacement of network infrastructure components such as switches, routers, firewalls and network provider demarcation, security and availability appliances, etc., following the hospital's ITIL change management processes.
- Maintain and monitor network infrastructure security, including ownership of regular network penetration testing and remediation, monitoring of corporate and guest Wi-Fi environments, IDS/IPS, maintaining all equipment software and policy level currency with industry best practices and in-line with the evolving global threat landscape.
- Author, develop, maintain and periodically review operational documentation and practices related to network services.
- Participate in relevant public sector competitive procurement processes and participate in requirements development as well as RFP evaluations.
- Responsible for ensuring that the Enterprise network environment is kept current, state-of-the-art, secure, robust and fault-tolerant, as a critical foundational infrastructure for delivering "The Future of Healthcare" to WCH staff, providers, researchers and most of all, our patients.
