Summary of Duties, but not limited to:

- Organizes the daily activities of the Clinic for the provision of patient care, including managing patient flow
- Identifies, prioritizes and responds to patient's problems and obtains patient's history
- Performs a variety of medical procedures including: wound dressings, debridements, compression wrapping, Doppler assessments, nail care; assist with biopsies, application of pressure bandages
- Using solution-focused approach assists patients to make realistic short and long term goals
- Provide extensive patient education related to wound care
- Liaises with inter-disciplinary physicians, nurses, chiropodists, and other staff to ensure interdisciplinary team functions efficiently and effectively and ensures continuity of patient care
- Informs patients of procedure results (e.g. lab, radiology or other investigative procedures) as required and organizes necessary follow-up arrangements
- Responds to and triages patient phone calls, gives advice as appropriate
- Assess social needs and connect with required resources
- Liaise with Community Care Access Centres
- Participate in teaching medical students and nursing students
- Documentation in the Electronic Patient Record
- Ensures medical supplies are available in the procedure rooms for use of the clinicians
