1.0 Welcome and Call to Order

The meeting was called to order at 1701 hours. D. Walwyn welcomed Leslie McCarley, President and CEO of Women's College Hospital Foundation and thanked Chaim Cutler as Interim President and CEO during the search.

4.0 Patient Experience Story

H. McPherson shared a patient experience by an individual who had participated in the Chronic Pelvic Pain Group Program, highlighting the options, information and support provided in the context of their complex condition and range of care and care navigation needs.

5.0 Current Healthcare Landscape and Future Trends

J. Woodman provided an overview of the current Ontario healthcare landscape and future healthcare trends. The presentation also offered insight into the current WCH patient population demographics and volumes across clinical program areas.

It was noted that WCH has implemented a new demographic survey as mandated by Ontario Health. When available, this data will provide information to support decision making about access, cultural safety, and approaches to impact health equity.

J. Woodman informed members that we continue to look at future trends that include technology, virtual reality, artificial intelligence and shifting care delivery into ambulatory and home care settings.

Members had a thorough discussion around technology and AI being considered with a new strategic plan.

D. Walwyn provided the following update:

- Members were informed that the Executive Committee met on September 20, 2023, and minutes were included in the material.
- At the executive committee meeting, members discussed the next board retreat and reviewed the timeline
 of the new strategic plan. Members recommended scheduling a board retreat on Saturday, March 2, 2024,
 from 9am-3pm in the Pink Cube.
- Nora Aufreiter, Chair of Unity Health and Carol Annett, Chair of Sunnybrook set up a meeting for interested board chairs of TAHSN hospitals to meet and share information, ideas, and experiences. The first meeting is scheduled on October 5, 2023.
- The description of the Strategy Advisory roles was included in the materials. The purpose of the role is to provide additional strategic advice to hospital management during the development of the hospital strategic plan. Members who are interested were asked to please inform D. Walwyn or J. Woodman.

8.0 CEO Report

H. McPherson's report was included in the material. She additionally reported on the following:

- Toronto Academic Health Science Network (TAHSN) CEO committee, chaired by H. McPherson, met last week. The TAHSN equity committee distributed a demographic survey for hospital boards and senior teams to complete. Results will be shared at the upcoming TAHSN CEO committee.
- Women's College Hospital received a memo from Deputy Minister of Health, Dr. Catherine Zahn, that the Ministry intends to support hospitals by providing additional financial support pertaining to Bill 124 that has added pressure to the hospital budget.
- National Day for Truth and Reconciliation is observed annually on September 30. This year the Centre for Wise Practices in Indigenous Health hosted a panel discussion focused on the intersections of art and health. This important day was also recognized through the sale of orange shirts and a food drive.
- WCH held its first clinical extern program in the spring and welcomed 15 clinical externs. The highly successful program was made possible through additional funding from Ontario Ministry of Health and contributes to our efforts to build a strong pipeline of clinical talent at WCH.
- Congratulations to Jennifer Price, Vice President Clinical Programs and Corporate Nursing and Professional Practice Executive, as co-investigator on a CIHR National Women's Health Research Initiative: Pan-Canadian Women's Health Coalition – Hubs grant and to Dr. Rulan Parekh, WCH Physician, Scientist and Vice President Academics, who received a grant for her project *Insight into Nephrotic Syndrome: Investigating Genes, Health, and Therapeutics.*
- WCH Healthcare Breakthrough Challenge is a new initiative in partnership with WCH Foundation that will fund innovative projects in clinical care, research, quality improvement and education linked to the hospital's strategic priorities. A total of 22 applicants submitted projects and top candidates will be presenting to donors and community members on November 29, 2023.
- On November 8, 2023, WCH will be hosting "Healthy Cities, Healthy People" in the WCH Auditorium and Pink Cube from 3:00pm to 6:00pm.
